**TRADEMARK RELEASE**

THIS TRADEMARK RELEASE is made as of December 10, 2021, by VARAGON CAPITAL PARTNERS AGENT, LLC, as administrative agent (in such capacity, "Administrative Agent") for all Lenders, in favor of FLORIDA WATER PRODUCTS, LLC, a Florida limited liability company ("Grantor"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

**WITNESSETH:**

WHEREAS, Grantor and Administrative Agent were parties to that certain Trademark Security Agreement dated as of November 12, 2020 (the "Trademark Security Agreement"), pursuant to which Grantor granted to Administrative Agent, for its benefit and the benefit of the Lenders, and thereby reaffirmed its prior grant pursuant to the Guarantee and Collateral Agreement of, a continuing security interest in Grantor's entire right, title and interest in and to the Trademark Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on November 12, 2020, at Reel 7104, Frame 0710;

WHEREAS, Grantor has requested that Administrative Agent execute this Trademark Release to evidence the release of its security interest in Trademark Collateral and the reassignment of any and all rights Administrative Agent may have in the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby releases, terminates and discharges its security interest in all of Grantor's right, title and interest in, to and under the following (collectively the "Trademark Collateral"):

(a) each Trademark and Trademark Licenses providing for the grant by or to Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule 1 hereto, together with any renewals or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(b) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of each such Trademark, or (ii) injury to the goodwill associated with each such Trademark.

2. Administrative Agent hereby reassigns and conveys to Grantor, without any representation or recourse by Administrative Agent, any and all right, title and interest Administrative Agent may have in and to the Trademark Collateral.


3. This Trademark Release shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
