## NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this “Agreement”), dated on or as of March 31, 2022, is made by **DALE MEDICAL PRODUCTS, INC.**, a Massachusetts corporation (the “**Grantor**”) with an address at 40 Kenwood Circle – Suite 7, Franklin, MA 02038, and **KEYBANK NATIONAL ASSOCIATION** (the “**Bank**”), with an address at 127 Public Square, Cleveland, OH 44114, in connection with that certain Loan and Security Agreement by and between the Grantor and the Bank dated as of March 31, 2022 (as amended, restated, supplemented or otherwise modified from time to time, and together with the Riders thereto, the “Loan Agreement”).

WHEREAS, pursuant to the Loan Agreement, the Bank has agreed to make extensions of credit to the Grantor upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Loan Agreement, the Grantor granted to the Bank a security interest in its Intellectual Property, including Trademarks; and

WHEREAS, the Grantor has duly authorized the execution, delivery and performance of this Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Bank to make extensions of credit to the Grantor on the terms and subject to the conditions of the Loan Agreement, the Grantor agrees, for the benefit of the Bank, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble, have the meanings provided or provided by reference in the Loan Agreement.

SECTION 2. Confirmation of Security Interest. The Grantor hereby confirms that pursuant to the Loan Agreement, subject to existing licenses to use the Trademarks granted by such Grantor in the ordinary course of its business, it granted to the Bank a security interest in all of the Trademarks of the Grantor (including, without limitation, those items listed on Schedule A hereto) as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations of the Grantor.


SECTION 3. Purpose. This Agreement has been executed and delivered by the Grantor for the purpose of recording the security interest granted pursuant to the Loan Agreement with the United States Patent and Trademark Office. This Agreement is expressly subject to the terms and conditions of the Loan Agreement. The Loan Agreement (and all rights and remedies of the Bank thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Acknowledgment. The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Bank with respect to the security interest in the Trademarks are fully set forth in the Loan Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

SECTION 5. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.


