ASSIGNMENT OF TRADEMARK

This Trademark Assignment Agreement (the “**Assignment**”) is made and entered into as of March __, 2022 (the “**Effective Date**”), by and between Creation Technologies, a Canada corporation, having a principal address at 3939 N. WHEREAS, Assignor owns the entire right, title and interest in and to the trademark registrations listed in Exhibit A attached hereto (the “**Marks**”); and

WHEREAS, Assignee is desirous of acquiring the Marks, and Assignor is desirous of assigning the Marks to Assignee pursuant to the terms and conditions of this Assignment.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties, intending to be legally bound, agree as follows:

1. **Assignment.** Assignor does hereby assign and transfer to Assignee all right, title and interest in and to the Marks, along with the goodwill of the business symbolized by the Marks, and all causes of action relating thereto, whether arising before or after the date of this assignment.
2. **Effect of Assignment.** The Marks shall be held and enjoyed by Assignee and its successors and assigns, for its exclusive use and benefit as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment not been made.
3. **Governing Law.** The validity, construction and performance of this Assignment will be governed by the laws of Delaware State, without giving effect to that body of laws pertaining to conflict of laws that would subject a matter to the laws of another jurisdiction.
4. **Entire Agreement; Amendment.** Upon execution, this Assignment shall constitute the entire agreement among the Parties hereto with respect to the subject matter hereof and merges all other prior or contemporaneous communications. This Assignment shall not be amended except by a written agreement dated subsequent to the date of this Assignment and signed on behalf of the Parties hereto by their respective duly authorized representatives.
