**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”), effective as of this 31<sup>st</sup> day of March, 2022, is made by **TRUIST BANK**, with an address at 3333 Peachtree Road, 3rd Floor, Atlanta, Georgia 30326, in its capacity as collateral agent for the Secured Parties (in such capacity, together with its successors and permitted assigns, the “Collateral Agent”) in favor of **OLE SMOKY DISTILLERY, LLC**, a Tennessee limited liability company (“Grantor”), as follows:

**WITNESSETH**

WHEREAS, the Grantor and the Collateral Agent are party to that certain Pledge and Security Agreement, dated as of April 2, 2021 (as amended, restated, amended and restated, replaced, supplemented or otherwise modified from time to time, the “Security Agreement”), pursuant to which the Grantor granted to the Secured Parties, a security interest in and continuing lien on, certain intellectual property rights owned by the Grantor;

WHEREAS, in furtherance of the Security Agreement, the Grantor executed a Trademark Security Agreement, dated April 2, 2021 (the “Trademark Security Agreement”), which was duly recorded on April 5, 2021, at Reel/Frame 7244/0193 in the United States Patent and Trademark Office;

WHEREAS, the Collateral Agent wishes to release and restore all right, title and interest in and to the Trademark Collateral (as that term is defined in the Trademark Security Agreement) to the Grantor and to terminate those liens and encumbrances created by the Trademark Security Agreement and the Security Agreement in respect of the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby grants, assigns, transfers and conveys, without recourse or warranty, to the Grantor all of its rights, title and interest in the Trademark Collateral, including but not limited to the Trademarks listed on Schedule 1 attached hereto and hereby terminates, releases, discharges, quitclaims and relinquishes unto the Grantor any and all security interests and liens it has against the Trademark Collateral, including but not limited to the Trademarks listed on Schedule 1 attached hereto.

Unless otherwise defined herein, the terms defined in the Security Agreement or the Trademark Security Agreement and used herein have the meaning given to them in the Security Agreement or the Trademark Security Agreement, as applicable.

The Collateral Agent hereby agrees, at Grantor’s sole cost and expense, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the intents and purposes of this Release.

The Grantor, and any successor to the Grantor (including any person or entity hereafter holding any right, title or interest in or to the Trademark Collateral) is hereby authorized to record this Release with the United States Patent and Trademark Office.
