MEMORANDUM OF SECURITY INTEREST IN TRADEMARKS

Ladies and Gentlemen:

Pursuant to the Security Agreement, dated as of September 6, 2017 (as amended, restated, amended and restated, supplemented, extended, refinanced or otherwise modified from time to time, the “Security Agreement”), Integrated Reporting Is Simple LLC, a Nevada limited liability company (the “Assignor”), has granted to AB PRIVATE CREDIT INVESTORS LLC, a Delaware limited liability company, as administrative and collateral agent for certain lenders, as Assignee (the “Assignee”) a first lien security interest in the Trademarks (as such term is defined in the Security Agreement), excluding any intent-to-use trademark application filed in the United States Patent and Trademark Office pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. Section 1051, prior to the accepted filing of a “Statement of Use” and issuance of a “Certificate of Registration” pursuant to Section 1(d) of the Lanham Act or an accepted filing of an “Amendment to Allege Use” whereby such intent-to- use trademark application is converted to a “use in commerce” application pursuant to Section 1(c) of the Lanham Act, including the trademarks listed on the annexed Exhibit A, and all applications, registrations, renewals and proceeds (including accounts receivable and royalties) thereof (the “Trademarks”), together with the goodwill of the business connected with the use of and symbolized by the Trademarks. The Assignee’s security interest in the Trademarks can only be terminated in accordance with the terms of the Security Agreement.


