RELEASE OF TRADEMARK SECURITY AGREEMENT

This **RELEASE OF TRADEMARK SECURITY AGREEMENT** ("Trademark Release") is made as of April 1, 2022 ("Effective Date") executed by Capital One, National Association ("Administrative Agent"), in favor of Advantice Health, LLC (formerly known as Moberg Pharma North America LLC) ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated March 29, 2019; capitalized terms used but not defined herein shall have the meaning ascribed to such terms in the Trademark Security Agreement or the Guaranty and Security Agreement (as defined in the Trademark Security Agreement, as applicable) by the Grantor in favor of the Administrative Agent, dated as of March 29, 2019, Grantor granted to Agent a continuing Lien on and security interest in and to all of the Grantor's right, title and interest in the following Collateral owned by such Grantor in its own name (collectively the "Trademark Collateral") including all goodwill of the business connected with the use of, and symbolized by, the Trademark Collateral to secure the obligations;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 29, 2019 at Reel 6606 Frame 0786;

WHEREAS, the Administrative Agent wishes to terminate the Trademark Security Agreement and release and restore all right, title and interest in and to the Trademark Collateral to the Grantor and to dissolve those liens and encumbrances created by the Trademark Security Agreement in respect of the Trademark Collateral as set forth on Schedule I attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests or Liens it has and all of its right, title and interest in, to and under the Trademark Collateral, whether now owned or hereafter created or acquired by the Grantor, and (iii) reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by the Administrative Agent, any and all of the Administrative Agent's right, title and interest in and to the Trademarks and the Trademark Applications.
