**RELEASE OF CONFIRMATORY GRANT OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY  
(Trademarks)**

This RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (Trademarks) (the “**Release**”) is effective as of the 30<sup>th</sup> day of March, 2022, by and between:

**VERVENT INC.**, a Delaware corporation, having an address of 10182 Telesis Court, San Diego, CA 92121 (“**Grantor**”), and

**U.S. BANK NATIONAL ASSOCIATION, AS ADMINISTRATIVE AGENT**, having an address of 800 Nicollet Mall, Minneapolis, MN 55402, for itself and as Secured Party for the Lenders, (the “**Administrative Agent**”).

**W I T N E S S E T H:**

A. First Portfolio Servicing Inc., a Delaware corporation, First Portfolio Servicing Holdings Inc. and Administrative Agent, among others, entered into that certain Credit Agreement dated as of July 12, 2019 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”).

B. Grantor and Administrative Agent, among others, are parties to that certain Security Agreement dated as of July 12, 2019 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), pursuant to which Grantor pledged, assigned and granted a security interest in favor of Administrative Agent in certain Collateral (as defined therein).

C. Grantor and Administrative Agent are parties to that certain Intellectual Property Security Agreement Supplement (the “**IP Security Agreement Supplement**”) dated as of July 1, 2020, which was recorded with the United States Patent and Trademark Office (“**PTO**”) on July 07, 2020, at Reel 6993, Frame 0060.

D. Grantor has satisfied all of the Obligations under the Credit Agreement and the Security Agreement and requested that the Administrative Agent terminate and release its security interests in and liens on the Collateral.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1. Definitions. All capitalized terms not defined in this Release shall have the respective meaning given to them in the Credit Agreement or the Security Agreement or the IP Security Agreement Supplement as the case may be.

2. Termination and Release of Security Interest. The Administrative Agent hereby terminates, releases, and discharges its security interest in and liens on the Collateral, including, without limitation, the Trademarks listed on Exhibit A hereto, and the Administrative Agent hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the

Administrative Agent's right, title and interest in and to such Trademarks, effective as of the date set forth above.
