RELEASE OF TRADEMARK SECURITY AGREEMENT

April 7, 2022

WHEREAS, pursuant to the Amended and Restated Trademark Security Agreement, dated July 15, 2021, recorded in the United States Patent and Trademark Office at Reel 7357, Frame 0336 on July 16, 2021 (the "Trademark Security Agreement"), Valencia Pipe Company ("Releasee"), created in favor of Valley National Bank, successor by merger to Bank Leumi USA, in its capacity as agent (in such capacity, together with its successors and assigns, "Releasor"), a security interest in all of the Trademark Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, Releasee has requested and Releasor has agreed to provide this Release of Trademark Security Agreement to confirm the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, intending to be legally bound and for other good and valuable consideration, the sufficiency of which is hereby acknowledged, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.


2. Release of Security Interest. Releasor hereby (i) terminates, releases, relinquishes and discharges its security interest in the Trademark Collateral, including without limitation, all of Releasee's right, title and interest in and to the Trademarks listed on Schedule 1 hereto, and (ii) reassigns, transfers and conveys to the Releasee any right, title and interest of the Releasor in the Trademark Collateral, in each case, without recourse or representation or warranty, express or implied, of any kind.


