**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (“Release”) is made as of this 30th day of December, 2021, by PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent (“Agent”), in favor of EOTECH, LLC, a Michigan limited liability company (“Grantor”).

WHEREAS, Grantor entered into a certain Intellectual Property Security Agreement, dated July 31, 2020 with Agent, notice of which was recorded with the United States Patent and Trademark Office on August 19, 2020 at reel/frame 7029/0063 and reel/frame 053543/0563 (the “IP Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, Grantor granted to Agent, under the terms of the IP Security Agreement, a continuing security interest in favor of Agent, in and to all of their right, title and interest in and to the IP Collateral, including without limitation the intellectual property listed in Schedule I attached hereto.

WHEREAS, Agent has agreed to terminate and release its security interest in all such IP Collateral as herein provided.


FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby (a) releases, terminates and discharges its security interest in the IP Collateral, including the intellectual property listed on Schedule I attached hereto and made a part hereof, (b) terminates the IP Security Agreement and (c) assigns, transfers and conveys to Grantor any right, title or interest, including the security interest, it may have in the IP Collateral of Grantor. Grantor, or any successor to Grantor (including any person or entity

hereafter having any right, title or interest in or to the IP Collateral of Grantor), is hereby authorized to record this Release in the United States Patent and Trademark Office.
