**NOTICE OF SUCCESSOR AGENT AND ASSIGNMENT OF SECURITY INTEREST
(SECOND LIEN)**

This Notice of Successor Agent and Assignment of Security Interest (Second Lien), dated as of April 1, 2022 (this "**Notice**"), is entered into among Credit Suisse AG, Cayman Islands Branch ("**Credit Suisse**"), as Collateral Agent under the Collateral Agreement (defined below) and Security Agreements (Second Lien) (defined below) (the "**Resigning Agent**"), and Computershare Trust Company, N.A. ("**Computershare**"), in its capacity as successor Collateral Agent (the "**Successor Agent**") pursuant to the Agency Assignment Agreement (defined below). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Collateral Agreement, Security Agreements (Second Lien), and Agency Assignment Agreement (defined below).

W I T N E S S E T H:

WHEREAS, Academi LLC, a Delaware limited liability company and Constellis, Inc., a Delaware corporation, and the below listed entities (each a "**Pledgor**"), and the Resigning Agent are party to that certain (i) Collateral Agreement (Second Lien), dated as of March 27, 2020, as amended, restated, supplemented or otherwise modified from time to time, the ("**Collateral Agreement**"), (ii) Notice of Grant of Security Interest in Trademarks (Second Lien), Notice of Grant of Security Interest in Patents (Second Lien), and Notice of Grant of Security Interest in Copyrights (Second Lien), each dated as of March 27, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the "**Security Agreements (Second Lien)**"); and (iii) Resignation, Amendment and Appointment Agreement (Second Lien), dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "**Agency Assignment Agreement**"), by and among the Resigning Agent, the Successor Agent, the Borrower, certain Lenders and the other Loan Parties; and

WHEREAS, pursuant to the Loan Documents, certain Loan Parties granted to the Resigning Agent a security interest in certain collateral;

WHEREAS, the Resigning Agent and applicable Loan Parties entered into the Security Agreements (Second Lien);

WHEREAS, the Security Agreements (Second Lien) were recorded in the United States Patent and Trademark Office on March 27, 2020 at Reel 6902 and Frame 0001 for trademarks, and at Reel 052252 and Frame 0343 for patents, and sent in for recordation to the United States Copyright Office on April 3, 2020 for copyrights; and

WHEREAS, pursuant to the Agency Assignment Agreement, the Resigning Agent resigned as, and Successor Agent was appointed and accepted appointment as, the Collateral Agent with all the rights, powers, privileges and duties of the Resigning Agent as Collateral Agent under the applicable Loan Documents, including in and to the Security Agreements (Second Lien).

NOW, THEREFORE, the parties agree as follows:

1. Pursuant to the terms and conditions set forth in the Agency Assignment Agreement, the Resigning Agent ceased to be the Collateral Agent under the Loan Documents and is succeeded to and replaced by the Successor Agent as Collateral Agent under the Loan Documents, and the Resigning Agent transferred, assigned, granted and conveyed unto the Successor Agent all of its right, title and interest in and to the Security Agreements (Second Lien) with all attendant liens, rights, title, assignments and interests (including security interests) pertaining to or arising from the Security Documents, including in and to the Trademark Collateral, Patent Collateral, and Copyright Collateral scheduled on the Security Agreements (Second Lien). Nothing herein shall be deemed to terminate, interrupt, or impair the continuity of the security interest in and to the Collateral granted to the Resigning Agent under the Loan Documents, including the Security Agreements (Second Lien) and the Collateral identified on Schedule A attached hereto, which security interest is now succeeded by and transferred to the Successor Agent.

2. All terms set forth in the Agency Assignment Agreement are hereby incorporated herein by reference with the same force and effect as though fully set forth herein. To the extent that the terms set forth herein are inconsistent with the terms of the Agency Assignment Agreement, the terms set forth in the Agency Assignment Agreement shall apply.

3. This Notice may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

4. This Notice and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.


