(“Holdings”), SAFARILAND, LLC, a Delaware limited liability company (“Safariland”), SAFARILAND GLOBAL SOURCING, LLC, a Delaware limited liability company (“Global Sourcing”), HORSEPOWER, LLC, a Delaware limited liability company (“Horsepower”), MED-ENG, LLC, a Delaware limited liability company (“Med-Eng”), SENCAN HOLDINGS, LLC, a Delaware limited liability company (“Sencan Holdings”), ATLANTIC TACTICAL, INC., a Pennsylvania corporation (“ATI”), LAW MEN’S DISTRIBUTION, LLC, a Delaware limited liability company (“Lawmen’s Distribution”), SAFARILAND DISTRIBUTION, LLC, a Delaware limited liability company (“Distribution”), UNITED UNIFORM DISTRIBUTION, LLC, a Delaware limited liability company (“United Uniform”), GH ARMOR SYSTEMS, INC., a Delaware corporation (“GH Armor”), DEFENSE TECHNOLOGY, LLC, a Delaware limited liability company (“Defense Technology”), MED-ENG HOLDINGS ULC, a British Columbia unlimited liability company (“Med-Eng Holdings”), and PACIFIC SAFETY PRODUCTS INC., a Canadian corporation (each a “Grantor”, and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, pursuant to that certain Term Loan and Security Agreement dated as of November 17, 2020 among the Grantors, Agent, and others party thereto (as amended, restated, supplemented or otherwise modified from time to time, the “Loan Agreement”) and the Trademark Security Agreement dated as of November 17, 2020 by and among the Grantors and Agent and recorded on November 17, 2020 with the Trademark Division of the United States Patent and Trademark Office at Reel/Frame 7108/0820 (the “Trademark Security Agreement”), each Grantor granted, assigned and pledged to Agent, for the benefit of the Secured Parties, a continuing security interest in and Lien upon the Trademark Collateral, including but not limited to the Trademarks set forth on Schedule 1 hereto;

Reel/Frame 5948/0281) and Successor Agent to Virtus Group, LP, as Successor Agent to Wilmington Trust, National Association pursuant to the Agency Resignation, Appointment, Assumption and Waiver Agreement dated as of November 18, 2016 and the Assignment of Intellectual Property Security Agreements dated as of November 18, 2016 and recorded November 21, 2016 with the Trademark Division of the United States Patent and Trademark Office at Reel/Frame 5932/0534, released the entirety of its continuing security interest in and Lien upon the Trademark Collateral set forth therein or otherwise subject to any of the foregoing, the Loan Agreement referenced therein, or otherwise.





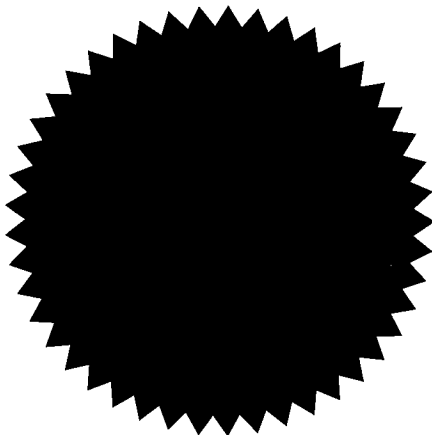
