TERMINATION AND RELEASE OF FIRST LIEN TRADEMARK SECURITY AGREEMENT

This Termination and Release of First Lien Trademark Security Agreement ("Release") is entered into as of April 11, 2022 ("Reference Date"), by IceArizona Hockey Co LLC, a Delaware limited liability company, IceArizona Holdings LLC, a Delaware limited liability company, and IceArizona AHL Co LLC, a Delaware limited liability company (collectively, "Grantors") and MGG Investment Group LP, as collateral agent for the Secured Parties (in that capacity, together with its successors and permitted assigns, the "Collateral Agent").

RECITALS

Pursuant to the terms of a First Lien Trademark Security Agreement (US) dated July 29, 2019 (the "Security Agreement") between the Grantors and the Collateral Agent and recorded with the U.S. Patent and Trademark Office on July 30, 2019 (Trademark Reel 006714 and Frame 0831), each of the Grantors granted to the Collateral Agent a security interest in certain Trademark Collateral (as defined in the Security Agreement), including, without limitation, the Trademark Collateral referenced on Schedule 1 attached hereto.

The Collateral Agent has agreed to terminate and release its security interest in and first priority lien on all of the Trademark Collateral as set forth in this Release.

TERMS

In consideration of the mutual promises made in this Agreement and for other good and valuable consideration, the receipt and sufficiency of which are acknowledged, the Collateral Agent and each of the Grantors agree as follows:

- 1. Definitions.** Capitalized terms used in this Release have the meaning set forth in the Security Agreement unless otherwise defined in this Release.
- 2. Termination and Release.** The Collateral Agent hereby terminates and releases its security interest in and first priority lien on all of the Trademark Collateral effective as of the Reference Date.
- 3. Acknowledgment and Acceptance.** Each of the Grantors hereby acknowledges and accepts the foregoing termination and release by the Collateral Agent.
- 4. Counterparts.** This Release may be executed in any number of counterparts, each of which is deemed an original, but all of which together constitute one and the same

instrument. The exchange of counterparts of this Release, signature pages, and all ancillary documents by facsimile, portable document format (PDF), or email to all the parties constitutes execution and delivery of this Release. The parties authorize each other to detach and combine signature pages and consolidate them into a single document. Any one of the completely executed counterparts shall be sufficient proof of this Release.
