TERMINATION AND RELEASE OF FIRST LIEN TRADEMARK SECURITY AGREEMENT

This Termination and Release of First Lien Trademark Security Agreement ("<u>Release</u>") is entered into as of April 11, 2022 ("<u>Reference Date</u>"), by IceArizona Hockey Co LLC, a Delaware limited liability company, IceArizona Holdings LLC, a Delaware limited liability company, and IceArizona AHL Co LLC, a Delaware limited liability company (collectively, "<u>Grantors</u>") and MGG Investment Group LP, as collateral agent for the Secured Parties (in that capacity, together with its successors and permitted assigns, the "<u>Collateral Agent</u>").

- **4. Counterparts.** This Release may be executed in any number of counterparts, each of which is deemed an original, but all of which together constitute one and the same
