TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS** (this "Termination and Release"), dated as of April 13, 2022, by **CRYSTAL FINANCIAL LLC D/B/A SLR CREDIT SOLUTIONS**, in its capacity as administrative agent and collateral agent for the Secured Parties (in such capacity, the "Agent").

WITNESSETH:

WHEREAS, reference is made to that certain ABL Loan and Security Agreement, dated as of October 19, 2020 (as amended, restated, supplemented or otherwise modified from time to time, including all schedules thereto, the "Loan Agreement"), by and among, among others, **TRUE RELIGION APPAREL, INC.**, a Delaware corporation (the "Borrower Representative"), **GURU DENIM LLC**, a California limited liability company (together with the Borrower Representative, the "Trademark Grantors") and, collectively with the other loan parties, the "Loan Parties"), the lenders from time to time party thereto (the "Lenders") and the Agent;

WHEREAS, pursuant to (a) that certain Trademark Security Agreement, dated as of November 15, 2019 (the "2019 Security Agreement"), and (b) that certain Trademark Security Agreement, dated as of October 19, 2020 (the "2020 Security Agreements"), and together with the 2019 Security Agreement, the "Security Agreement"), a lien on and security interest (the "Security Interest") was granted by the Trademark Grantors to the Agent in the Trademarks;

WHEREAS, the 2019 Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 22, 2019, at Reel/Frame 6801/0658 and the 2020 Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on October 20, 2020, at Reel/Frame 7081/0089; and

WHEREAS, the Agent now desires to terminate and release the Security Agreements and the entirety of its Security Interest in the Trademarks including those Trademarks listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby agrees as follows:

1. **Definitions**. Capitalized terms not defined herein have the meanings set forth in the Security Agreements.
2. **Release of Security Interest**. The Agent hereby terminates, releases and discharges the Security Agreement, any and all Security Interest in the Trademarks, including those Trademarks listed on Schedule 1 hereto, and any right, title or interest of the Agent in to, or under such Trademarks shall hereby cease and become void.
3. **Recordation**. The Agent hereby authorizes the Loan Parties and their designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Loan Parties' expense.
