TRADEMARK ASSIGNMENT

This Assignment of Trademark Rights (the "*Trademark Assignment*"), effective October 15, 2021 (the "*Effective Date*"), by and between Richard Davies, an individual, having an address of Tewkesbury, The Willows, Lincoln Green Lane, Gloucestershire, United Kingdom, GL207DN (the "*Assignor*") and Slainte Brands International Limited, a private company duly organized and existing under the laws of Ireland, having a business address of Unit 6a, Stadium, Business Park, Ballycoolin Road, Dublin, Ireland (the "*Assignee*").

WHEREAS, Assignor desires to convey, transfer, and assign to Assignee certain trademarks together with certain other intellectual property assets owned by Assignor and Assignee desires to accept the trademarks and other intellectual property pursuant to this Trademark Assignment; and

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor's worldwide right, title, and interest in and to the following:

(a) the trademarks set forth on Schedule A attached hereto (the "*Assigned Trademarks*"), together with the transfer of that portion of the Assignor's business to which the Assigned Trademarks pertain, and that business is ongoing and existing, and together with the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks;

(b) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;


(c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Counterparts. This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement.
