**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY
SUBJECT TO FIRST LIEN LOAN DOCUMENTS**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), date as of April 7, 2022, is made by General Electric Company, as successor by merger of General Electric Capital Corporation, with a place of business located at 901 Main Avenue, Norwalk, CT 06851-1168 (the "Secured Party"), in favor of Penton Media, Inc. and Penton Business Media, Inc., with a place of business located at 249 West 17th Street, Fourth Floor, New York, New York 10011 (collectively, the "Grantors").

WHEREAS, pursuant to the First Lien Loan Documents, as defined in the Order and Plan of Reorganization in re Penton Business Media Holding, Inc., et., al., dated as of March 5, 2010, approved and confirmed by the Chief United States Bankruptcy Judge of the United States Bankruptcy Court, Southern District of New York and recorded on May 10, 2010 with the United States Patent and Trademark Office at Reel 004202, Frames 0539-0601 (the "Order"), a copy of which is attached hereto and made a part hereof, the Grantors granted to the Secured Party a first lien security interest in and to the intellectual property collateral as described in the First Lien Loan Documents and listed in the Trademark Assignment, as copy of which is attached hereto and made a part hereof;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:


1. Release. The Secured Party (as Administrative Agent), without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the copyrights, patents and trademarks of the Grantors and all proceeds of any of the foregoing (the "Intellectual Property Collateral"), including the copyright, patent and trademark registrations and applications set forth in First Lien Loan Documents, arising under the First Lien Loan Documents. If and to the extent that the Secured Party has acquired any right, title or interest in and to the Intellectual Property Collateral under the First Lien Loan Documents, the Secured Party, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.

2. Termination. The Secured Party, without representation or warranty of any kind, terminates and cancels the First Lien Loan Documents and any trademark security agreement that the Grantors may have executed and delivered for recording with the United States Patents and Trademark Office.

3. Governing Law. This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
