ACKNOWLEDGEMENT OF RELEASE dated as of April 14, 2022 (this "Acknowledgment"), by JPMORGAN CHASE BANK, N.A., as Administrative Agent, in favor of EXPEDIA GROUP, INC., a Delaware corporation (the "Company"), CARRENTALS.COM, INC., a Nevada corporation, EXPEDIA, INC., a Washington corporation, HOMEAWAY.COM, INC., a Delaware corporation, HOTELS.COM, L.P., a Texas Limited Partnership, ORBITZ, LLC, a Delaware limited liability company, and TRAVELSCAPE, LLC, a Nevada limited liability company (each, including the Company, a "Grantor" and collectively, the "Grantors").

Reference is made to (a) the Amended and Restated Credit Agreement, dated as of May 5, 2020, as heretofore amended (the "Credit Agreement"), among the Company, the Borrowing Subsidiaries from time to time party thereto, the Lenders from time to time party thereto and JPMorgan Chase Bank, N.A., as Administrative Agent and London Agent, (b) the Collateral Agreement referred to therein and (c)(i) the Patent and Trademark Security Agreement, dated as of May 5, 2020 and (ii) the Patent and Trademark Security Agreement, dated as of April 30, 2021 (together, the "Patent and Trademark Security Agreements"), in each case, among the Company, the other Grantors from time to time party thereto and the Administrative Agent. Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Collateral Agreement, as applicable.

Pursuant to the Collateral Agreement and the Patent and Trademark Security Agreements, the Grantors granted to the Administrative Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a security interest in all of the Grantors' right, title and interest in, to and under, among other things, the Patents set forth on Schedule I hereto (the "Released Patent Collateral") and the Trademarks set forth on Schedule II hereto (the "Released Trademark Collateral") and, together with the Released Patent Collateral, the "Released Patent and Trademark Collateral"), which security interests were recorded with the United States Patent and Trademark Office on (a) May 5, 2020 at Reel/Frame No. 052577/0759 and Reel/Frame No. 6930/0456 and (b) May 3, 2021 at Reel/Frame No. 056118/0829 and Reel/Frame No. 7278/0448.

As provided in the Collateral Agreement, the Administrative Agent has agreed to terminate and release its security interest in the Released Patent and Trademark Collateral, and the Grantors have requested that the Administrative Agent execute and deliver this Acknowledgement to evidence the release of the security interests granted to the Administrative Agent in the Released Patent and Trademark Collateral for filing and recordation with the United States Patent and Trademark Office.

Pursuant to Section 9.14 of the Credit Agreement and Section 5.13 of the Collateral Agreement, the Administrative Agent hereby relinquishes, terminates, cancels and releases all Liens created in favor of the Administrative Agent on, and any and all right, title and interest it may have or have acquired in, the Released Patent and Trademark Collateral pursuant to the Collateral Agreement or the Patent and Trademark Security Agreements; provided that this Acknowledgment is being made without recourse to, or any representation or warranty by, the

Administrative Agent. The Administrative Agent hereby authorizes and requests that this Acknowledgement be recorded at the United States Patent and Trademark Office, or any other applicable location.

This Acknowledgement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page (including any Electronic Signature) of this Acknowledgement by fax, emailed pdf or any other electronic means that reproduces an image of the actual executed signature page shall be effective as delivery of a manually executed counterpart hereof.


