**NOTICE OF TERMINATION AND RELEASE OF SECURITY INTEREST IN  
TRADEMARK RIGHTS**

This NOTICE OF TERMINATION AND RELEASE (this "Release"), dated as of March 29, 2022 (the "Effective Date"), is made by THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A., in its capacity as Notes Collateral Agent (the "Agent"), with respect to the grantor party identified on the signature page hereto ("Grantor").

WHEREAS, pursuant to the Indenture, dated as of March 20, 2019 (as amended and/or supplemented to the date hereof), among the Agent, the Grantor and certain other parties thereto (the "Indenture") and that certain Security Agreement, dated as of March 20, 2019 by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the "Security Agreement"), the Grantor granted to the Agent a security interest in and to certain collateral, including Trademarks;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Trademark Security Agreement, dated as of June 3, 2020 (the "Trademark Security Agreement"), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 3, 2020 at Reel 6954 and Frame 0830;

WHEREAS, the security interest was terminated and released by the Agent on November 1, 2021, in accordance with the terms of the Indenture and the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Trademark Security Agreement or the Security Agreement, as applicable.

Release. The Agent, without recourse, representation or warranty of any kind, hereby disclaims, releases, discharges, terminates and cancels any security interest in and to the Trademark Collateral, including the Trademarks set forth in Schedule 1 attached hereto (the "Released Trademarks") arising from the Security Agreement and the recordation of the Trademark Security Agreement and reassigns all right, title and interest it has in the Released Trademarks to the Grantor.

Further Assurances. Promptly upon request by the Grantor from time to time, the Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

Governing Law. This Release shall be governed by and construed in accordance with the laws of the State of New York, and shall be binding on the Grantor's and the Agent's representatives, successors, assigns and transferees.
