NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Nunc Pro Tunc Trademark Assignment (hereinafter referred to as "Assignment") is effective as of December 31, 2021 (the "Effective Date"), by and between LiDCO Group Limited (formerly known as LiDCO Group PLC) ("LiDCO Group") and its wholly-owned subsidiary, LiDCO Limited ("LiDCO Limited"), each being U.K. companies with their principal place of business at 402-3 Salisbury House, 29 Finsbury Circus, London, EC2M 5SQ, United Kingdom (hereinafter referred to collectively as "ASSIGNOR"), and Masimo Corporation, a Delaware corporation, having its principal place of business at 52 Discovery, Irvine, CA 92618 (hereinafter referred to as "ASSIGNEE").

WHEREAS, ASSIGNOR had adopted, used, was using, and was, to the best of its knowledge and belief, the owner of the trademarks listed in Schedule A, attached hereto and incorporated herein by this reference, and all other rights appurtenant thereto, including, but not limited to, all common law rights, trade name rights, causes of action, and the right to recover for past infringement (hereinafter collectively referred to as "Trademarks") worldwide;

WHEREAS, ASSIGNOR had acquired goodwill associated with and symbolized by said Trademarks and had not abandoned the same;

WHEREAS, ASSIGNEE desired to acquire all rights, title, and interest in and to the Trademarks worldwide;

WHEREAS, ASSIGNOR was willing to assign to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the Trademarks; and

WHEREAS, ASSIGNEE wishes to confirm the assignment of said Trademarks by ASSIGNOR to ASSIGNEE, as of the Effective Date.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby acknowledges and confirms the assignment to ASSIGNEE of all rights, title, and interest as ASSIGNOR had possessed on the Effective Date in and to the following:

- (1) the Trademarks set forth in Schedule A

together with the goodwill symbolized by said Trademarks with the transfer of certain tangible assets as indicia of said goodwill.




