**PREAMBLE**

By a Transfer Agreement effective as of January 1st, 2022 [hereinafter THE ASSIGNMENT], THE ASSIGNOR transferred to THE ASSIGNEE the full and entire ownership of the trademark applications and registrations relating to the name FERRLECIT, as listed in the schedule hereto [hereinafter THE TRADEMARKS].

THE PARTIES hereby wish to confirm the transfer of ownership of the TRADEMARKS for the purpose of its recordal on the corresponding Trade Mark Register.
