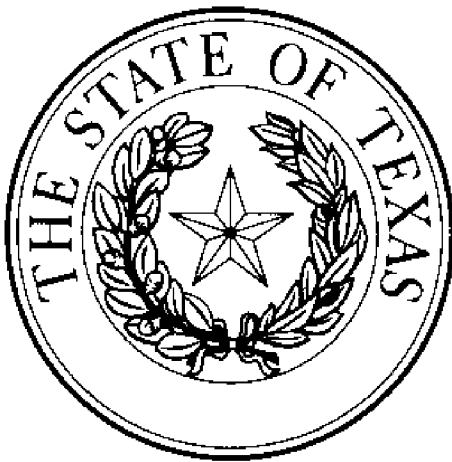

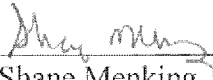
Pursuant to the provisions of Sections 10.101 and 10.103 of the Texas Business Organizations Code, Data Foundry, Inc., a Texas corporation, hereby adopts the following Plan of Conversion:

1. The name of the converting entity is “Data Foundry, Inc.”, a Texas corporation (the “*Converting Entity*”), and the name of the converted entity is “Data Foundry, LLC”, a Texas limited liability company (the “*Converted Entity*”).
2. The Converting Entity is continuing its existence in the organizational form of a limited liability company as the Converted Entity.
3. The Converted Entity is to be a limited liability company under the laws of the State of Texas.
4. The shares of common stock of the Converting Entity shall be converted into membership interests in the Converted Entity such that, immediately following the conversion, each shareholder of the Converting Entity shall own the same percentage interest in the Converted Entity that such shareholder owned in the Converting Entity immediately prior to the Conversion.
5. The conversion shall become effective upon the filing of the certificate of conversion and the certificate of formation of the Converting Entity with the Texas Secretary of State.
6. Attached as **Annex A** to this Plan of Conversion is the certificate of formation of the Converted Entity.

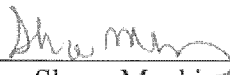
