## AMENDED AND RESTATED ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS (this "Assignment") is made and entered into as of January 24, 2022, by and between VOODOO DOUGHNUT, LLC, a Delaware limited liability company ("Assignor"), and FIRST INTERSTATE BANK, a Montana state-chartered bank ("Assignee").

WHEREAS, Assignor and Assignee are parties to that certain Collateral Assignment of Intellectual Property and Material Agreements dated January 24, 2022, by and among Assignor and Assignee, as the same may be hereinafter amended, modified, replaced, extended, and renewed (the "Collateral Assignment Agreement"), pursuant to which Assignor has agreed to assign, for collateral purposes, and Assignee has agreed to such assignment, of all of Assignor's right, title and interest in and relating to certain Trademarks and service marks as defined in the Collateral Assignment Agreement.

Assignment.** Assignor hereby grants to Assignee and its successors and assigns a continuing security interest in, and hereby collaterally assigns to Assignee (subject to Permitted Liens) the Trademarks and service marks including, without limitation those set forth on Exhibit A attached hereto and incorporated by reference and the goodwill of Assignor's business connected with and symbolized by the Trademarks and service marks.

**2. Further Assurances.** Assignor agrees to execute and deliver such other documents and to take all such other actions which the Assignee, its successors and/or assigns may reasonably request or that which is necessary to effect the terms of this Assignment.

**3. Miscellaneous.** This Assignment shall be governed by, and construed in accordance with, the laws of the state of Washington without reference to such state's principles of conflicts of law. This Assignment may not be supplemented, altered or modified in any manner except by a writing signed by all parties hereto. The failure of any party to enforce any terms or provisions of this Assignment shall not waive any of its rights under such terms or provisions. This Assignment shall bind and inure to the benefit of the respective parties and their assigns, transferees and successors. This Assignment and any amendments hereto may be executed in one or more counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument.
