AFFIDAVIT TO AFFIRM THE RELEASE OF SECURITY INTEREST

This Affidavit to Affirm the Release of Security Interest is effective as of _____ pursuant to the fulfillment of the loan obligations.

I, Phil Rogers, do hereby declare as follows.

1. I am the Chief Executive Officer of Square Enix Limited, an English Corporation.
2. Eidos Interactive Limited (“**Company**”) changed its name to Square Enix Limited.
3. Pursuant to that certain Deed of Charge of Intellectual Property, dated as of January 31, 2008 (the “**Security Agreement**”), Company granted Lloyds TSB Bank PLC (the “**Lender**”) a security interest (the “**Security Interest**”) in the trademark registration set forth on Schedule A attached hereto (the “**Trademark**”).
4. The Security Agreement was recorded at the United States Patent and Trademark Office (the “**USPTO**”) on April 15, 2008 at Reel/Frame 3759/0745 with respect to the Trademark.
5. To the best of my knowledge: (a) the obligations secured under the Security Agreement were satisfied; (b) Company repaid in full the loan made by Lender to Company under the Security Agreement; and (c) Lender released the Security Interest in the Trademark.
6. Due to unknown reasons, a release of the Security Interest was not previously filed with the USPTO.
7.
