The registrations numbers, registration dates for the servicemarks as assigned herein, are set forth in the attached Appendix A.

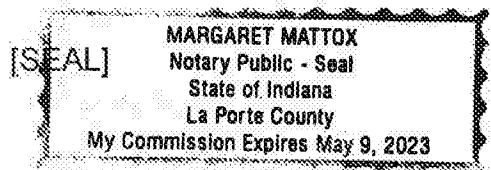
