**NOTICE OF SECURITY INTEREST**  
**U.S. TRADEMARKS**

WHEREAS, each of the entities listed on the signature page hereto (each a "**Grantor**" and collectively, the "**Grantors**"), as applicable, has adopted, used and are using the United States trademarks listed on the annexed Schedule A, which trademarks are registered in or subject to the trademark applications filed in the United States Patent and Trademark Office (the "**Trademarks**");

WHEREAS, pursuant to that certain Second Amended and Restated Credit Agreement, dated as of even date herewith (as may be amended, modified, supplemented or restated from time to time, the "**Credit Agreement**"), by and among Henny Penny Corporation, an Ohio corporation (the "**Borrower**"), the Guarantors (as defined therein) party thereto, the Lenders (as defined therein) party thereto and PNC Bank, National Association, as administrative agent for the Lenders (in such capacity, the "**Administrative Agent**"), the Grantors have entered into that certain Second Amended and Restated Patent, Trademark and Copyright Security Agreement, dated as of even date herewith (the "**Security Agreement**") in favor of the Administrative Agent (for itself and for the benefit of the Lenders); and

WHEREAS, pursuant to the Security Agreement, each Grantor has granted to the Administrative Agent (for itself and for the benefit of the Lenders), a mortgage on, pledge of and security interest in, all right, title and interest of such Grantor in and to the Trademarks, together with all the goodwill of the business symbolized by the Trademarks, and the registrations or applications for registration thereof, and all proceeds thereof, including, without limitation, any royalties, claims for infringement and proceeds of sale or other disposition thereof (the "**Trademark Collateral**") to secure the payment and performance of the Obligations (as defined in the Credit Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, each Grantor does hereby confirm its grant to the Administrative Agent (for itself and for the benefit of the Lenders) of a mortgage on, pledge of and security interest in the Trademark Collateral to secure prompt payment and performance of the Obligations.


