## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of April 14, 2022, is made by Coventure – Monolith Credit Opportunities GP, LLC, as collateral agent (in such capacity, together with its successors and assigns in such capacity, the “Agent”), in favor of Upanaway, LLC (the “Grantor”).

### WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of September 30, 2021 (the “Trademark Security Agreement”), made by the Grantor in favor of the Agent, the Grantor granted a lien on and security interest to the Agent (the “Security Interest”) in certain trademarks more fully described therein (the “Trademarks”);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on December 14, 2021, at Reel/Frame 7529/0830; and

WHEREAS, the Agent now desires to terminate and release its Security Interest in the Trademarks, including the Trademarks listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein have the meanings set forth in the Trademark Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges any and all Security Interest in the Trademarks, and any right, title or interest of the Agent in such Trademarks shall hereby cease and become void. The Agent, on behalf of the Lenders, hereby grants, assigns, transfers and conveys to the Grantor, effective as of the date of this Release, the entire right, title and interest in and to the Trademarks, including the Trademarks listed on Schedule 1 hereto.

3. Recordation. The Agent authorizes the Grantor and its designees to record this Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Grantor’s sole expense. The Agent agrees to take all further actions, and provide to the Grantors all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, in all cases, at the Grantor’s sole expense, to more fully and effectively effectuate the purposes of this Release.

4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
