- 3) The assignment (executed on February 2, 2006) inadvertently identified the Assignee (Himo, Inc. as a "Joint Stock Company of the Republic of Korea").
- 4) The Assignee, Himo, Inc., at the time of the execution of the assignment was a corporation of the Republic of Korea.

It is respectfully requested that the official records be corrected to remove the current entity status of the Assignee and replace it with: "a corporation of the Republic of Korea."
