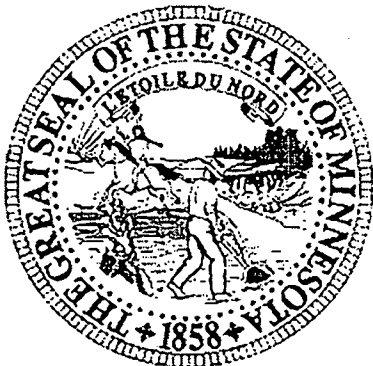


THIRD: The name of the surviving limited liability company is Forage Genetics International, LLC.

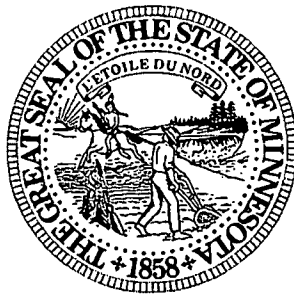
