**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “**Termination and Release**”) is granted as of April 19, 2022 by **SILICON VALLEY BANK**, as Administrative Agent (“**Agent**”), in favor of **CL RM ACQUISITION SUB, LLC**, a Delaware limited liability company (the “**Grantor**”).

WHEREAS, the Grantor executed and delivered a Trademark Security Agreement, dated as of August 14, 2020 (the “**Agreement**”), granting to Agent, with reference to the Guarantee and Collateral Agreement, a Lien and a security interest in all of its right, title and interest in, to and under the Trademarks (as defined in the Agreement), whether then owned or existing or at any time thereafter acquired or arising and wherever located, notice of which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on August 14, 2020 at Reel 7022, Frame 0698. Capitalized terms not otherwise defined herein have the respective meanings ascribed to them in the Agreement.

WHEREAS, Grantor has requested that Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks as herein provided; and

WHEREAS, Grantor has requested that Agent provide a document suitable for recording with the USPTO to evidence the release of Agent’s security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests thereunder and under the Guarantee and Collateral Agreement in, to and under the Trademarks, including, without limitation, those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO; and
3. agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.
