## NUNC PRO TUNC TRADEMARK ASSIGNMENT AGREEMENT

This Nunc Pro Tunc Trademark Assignment Agreement (“Agreement”) is made by and between Bond Manufacturing Co., Inc., a California corporation (“Assignor”), and GHP Group, Inc., a Delaware corporation (“Assignee”).

WHEREAS, Assignor has adopted and owns, itself or through a related company, the marks identified at Exhibit A (hereinafter the “Marks”);

WHEREAS, Assignee desires to acquire the Marks and all rights in the Marks, including the goodwill of the business associated with the Marks, as well as any and all common law rights in the Marks, and the trademark applications and registrations associated with the Marks;

WHEREAS, this Agreement shall have the legal force and retroactive effect of an assignment of rights by Assignor to Assignee on May 18, 2021;

NOW THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Assignor hereby conveys, transfers, and assigns to Assignee, as the successor to the portion of the ongoing and existing business to which the Marks pertain, all right, title, and interest in and to the Marks, including but not limited to all common law rights in the Marks and all applications and registrations for the Marks, together with the goodwill of Assignor’s business connected with the use of and symbolized by the Marks, and all rights corresponding thereto throughout the world, nunc pro tunc, now for then, effective as of May 18, 2021. Assignor further assigns to Assignee all rights to sue for and receive all damages occurring from past infringing uses of the Marks.

Assignor agrees that at any time and from time to time after execution of this assignment, at the request of Assignee and without further consideration, Assignor will execute and deliver such other instruments and take such action as Assignee may reasonably request to transfer, convey, and assign to Assignee, and to confirm Assignee’s right, title, and interest in and to the Marks, and to assist Assignee in exercising all rights with respect to the Marks.


Nothing in this assignment, express or implied, is intended or will be construed to confer upon, or give to, any person or entity, other than the parties to this assignment, any rights, remedies, obligations, or liabilities. This assignment will bind and inure to Assignee and Assignor and their respective successors and assigns. This assignment may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same.
