CERTIFICATE OF MERGER

merging

NETSOLACE, INC.,

a Delaware corporation

with and into

TKF HOLDINGS, INC.

a Connecticut Corporation

Pursuant to Sections 34-611 to 34-616

of the Connecticut Business Corporations Act

TKF Holdings, Inc., a corporation duly organized and existing under the laws of the State of Connecticut ("*Surviving Entity*") and NetSolace, Inc., a corporation duly organized and existing under the laws of the State of Delaware ("*Merging Company*"), do hereby certify that:

FIRST: Surviving Entity and Merging Company agree to merge and are parties to a Plan and Agreement of Merger, dated as of December 31, 2021 (the "*Merger Agreement*"), pursuant to which Merging Company will merge with and into Surviving Entity (the "*Merger*"), with Surviving Entity remaining as the successor or surviving entity. All conditions precedent to the Merger have been satisfied.

SECOND: The Surviving Entity is organized in the State of Connecticut. The principal office of the Surviving Entity is 980 Hammond Dr. Suite 1000 Atlanta, GA 30328.

THIRD: The Merger Agreement was adopted by the Surviving Entity in accordance with Connecticut Business Corporations Act ("*CBCA*"), Sections 34-611 to 34-616.

FOURTH: The Merger is permitted by the Delaware General Corporation Law (the "*DGCL*"). The Merging Company has complied with the requirements of, and approved the Merger Agreement in accordance with, DGCL Section 18-209.

FIFTH: The terms and conditions of the Merger under the Merger Agreement were duly authorized and approved by each party to this Certificate of Merger in the manner and by the vote required under its respective constituent documents, the CBCA, and the DGCL.


SIXTH: This Certificate of Merger, and the Merger, shall become effective on December 31, 2021 at 2:00pm Eastern Time.

SEVENTH: The Surviving Entity is deemed to have appointed the Secretary of State of the State of Connecticut as its agent for service of process in a proceeding to enforce any obligation or the rights of dissenting members of the Merging Company. The post office address within or without the State of Connecticut to which the said Secretary of State shall mail a copy of any process against the Surviving Entity served upon it is 980 Hammond Dr. Suite 1000 Atlanta, GA 30328.

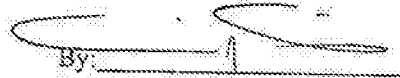
