

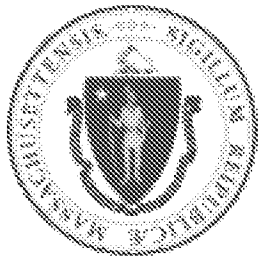

THE CORPORATION MAY CARRY ON SUCH OTHER ACTIVITIES AS MAY BE PERMITTED OF A CORPORATION ORGANIZED UNDER CHAPTER 180 OF THE GENERAL LAWS OF THE COMMONWEALTH OF MASSACHUSETTS, BUT ONLY TO THE EXTENT THAT THE CORPORATION IS NOT IN VIOLATION OF ANY APPLICABLE LAWS.

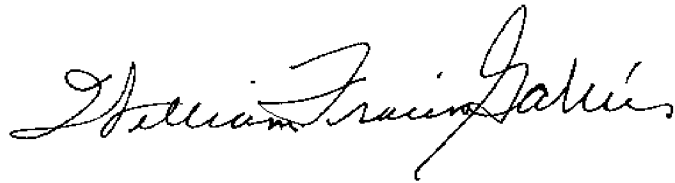
