RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of April 25, 2022, by CRESCENT DIRECT LENDING, LLC, as administrative agent ("Agent") to SQUAD LLC ("Grantor"). Reference is hereby made to that certain Trademark Security Agreement between the Grantor and the Agent dated as of December 22, 2017 and recorded in the United States Patent and Trademark Office ("USPTO") on December 22, 2017 at Reel/Frame 6235/0012 (the "IP Security Agreement"). Terms used but not defined in this Release shall have the meanings given thereto in the IP Security Agreement.

WHEREAS, pursuant to the IP Security Agreement, the Agent was granted a security interest in and to the intellectual property, including the Trademarks listed on Schedule 1 (the "Trademark Collateral");

WHEREAS, the Grantor has requested that the Agent terminate and release its security interests in and to the Trademark Collateral and execute and deliver evidence of such termination and release for filing in the USPTO; and

WHEREAS, the Agent has agreed to such termination and release.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent hereby releases and terminates all security interests and other interests it may have in the Trademark Collateral. Grantor (or its designee) is hereby authorized to file this Release with the USPTO and any other governmental authority.

The delivery of an executed counterpart of a signature page to this Release by email or facsimile shall be effective as delivery of a manually executed counterpart of this Release. The validity, construction and effect of this Release shall be governed by the laws of the State of New York (without giving effect to its principles of conflicts of law) and shall relate solely to the IP Security Agreement.
