**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of April 26, 2022, by **MUFG UNION BANK, N.A.**, a United States national association (the “Administrative Agent”) in favor of **LAKWOOD PATHOLOGY ASSOCIATES, INC.**, a New Jersey corporation with an address at 825 Rahway Avenue, Union, New Jersey 07083, **THERAPATH PARTNERS LLC**, a New York limited liability company with an address at 545 West 45<sup>th</sup> Street, New York, New York 10036, and **INFORM DIAGNOSTICS, INC.**, a Delaware corporation with an address at 6655 N, MacArthur Blvd., Irving, Texas 75039 (each, a “Grantor”, and collectively, the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors entered that certain Guarantee and Collateral Agreement, dated December 27, 2018 (as it has been amended, restated, amended and restated, replaced, supplemented or otherwise modified, the “Guarantee and Collateral Agreement”).

WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Grantors entered into a certain trademark security agreement dated December 27, 2018 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on December 28, 2018 at the United States Patent and Trademark Office at Reel 6511, Frame 0286.

WHEREAS, the Grantors granted the Administrative Agent, under the terms of the Trademark Security Agreement and the Guarantee and Collateral Agreement, a continuing Lien on and security interest in favor of the Administrative Agent, in and to all of each such Grantor’s right, title and interest in, to and under the Trademark Collateral, including without limitation the Trademarks listed in **Schedule A** (the “Security Interest”).

WHEREAS, the Administrative Agent has agreed to terminate the Guarantee and Collateral Agreement and the Trademark Security Agreement and release its Security Interest in and to all such Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**, as herein provided.

NOW, THEREFORE, for good and valuable consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, upon the terms set forth in this Trademark Release, hereby agrees as follows:

Section 1. Defined Terms. Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or Guarantee and Collateral Agreement, as applicable.

Section 2. Release. The Administrative Agent hereby releases, terminates and discharges any and all of its Security Interest in the Trademark Collateral of the Grantors, and reassigns, transfers and conveys to Grantors the any right, title and interest the Administrative Agent has in such Trademark Collateral.

Section 3. Recordation. The Administrative Agent hereby authorizes the Grantor and their designees to record this Trademark Release with the United States Patent and Trademark Office or any other applicable governmental authority at Grantor's expense.
