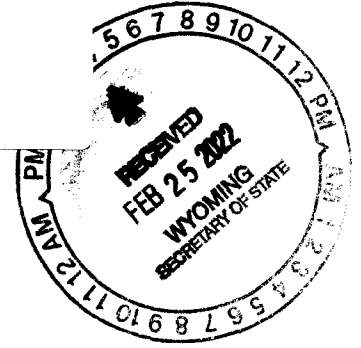

Articles of Organization
By Conversion

The undersigned, acting as an authorized person in relation to the conversion of Sinclair Oil Corporation, a Wyoming corporation (the “**Existing Entity**”), to Sinclair Oil LLC, a Wyoming limited liability company (the “**Converted Entity**”) hereby files these Articles of Organization in conjunction with the conversion of the Existing Entity to the Converted Entity.

This conversion of the Existing Entity into the Converted Entity has been adopted pursuant to W.S. Section 17-26-101 (which provides that any domestic entity may convert into another domestic entity), 17-16-1115 (which provides that a domestic corporation may be converted to a domestic limited liability company pursuant to Chapter 26 of Title 17, i.e., W.S. Section 17-26-101), and 17-29-1006 (which provides that an organization other than a limited liability company may be converted into a limited liability company pursuant to Chapter 26 of Title 17, i.e., W.S. Section 17-26-101).

1. The Existing Entity is hereby converted to a limited liability company, which is the Converted Entity.
2. The name of the newly converted limited liability company is Sinclair Oil LLC.
3. The former name of the entity, i.e., the name of Existing Entity, was Sinclair Oil Corporation.
4. The name and address of its initial registered agent is: CT Corporation System, 1908 Thomes Avenue, Cheyenne, WY 82001.
5. The mailing address of the limited liability company is: 550 E South Temple, Salt Lake City, UT 84130-0825.
6. The principal office address of the limited liability company is: 550 E South Temple, Salt Lake City, UT 84130-0825.
7. The Existing Entity was originally organized in Wyoming. The date of original organization of the Existing Entity in Wyoming was December 23, 2005. The filing ID number of the Existing Entity is 2005-000504777.
8. The conversion of the Existing Entity into the Converted Entity was unanimously approved by the shareholders of the Existing Entity.
9. One hundred percent of the votes cast by shareholders of the Existing Entity were cast in favor of conversion of the Existing Entity into the Converted Entity. The conversion of the Existing Entity into the Converted Entity was unanimously approved by the shareholders of the Existing Entity, in accordance with the Articles of Incorporation of the Existing Entity and authority given to the Existing Entity. The undersigned is the authorized representative of the sole shareholder

of the Existing Entity, and such person acts as the organizer to form the Converted Entity pursuant to W.S. Section 17-29-201.

10. The conversion of the Existing Entity into the Converted Entity is effective as of the filing of these Articles of Organization by Conversion. The effect of the conversion of the Existing Entity into the Converted Entity is as set forth in W.S. § 17-26-101(g), in that "Upon conversion, all property owned by the converting entity remains in the newly converted entity. All obligations of the converting entity continue as obligations of the newly converted entity. Any action or proceeding pending against the converting entity may be continued as if the conversion had not occurred."
