## **ASSIGNMENT AND ASSUMPTION OF OWNED BUSINESS INTELLECTUAL PROPERTY**

This Assignment and Assumption of Owned Business Intellectual Property (this “Assignment”) is made as of April 21, 2015, by and between Hillerich & Bradsby Co., a Kentucky corporation (“Assignor”), and Wilson Sporting Goods Co., a Delaware corporation (“Assignee”).

WHEREAS, Assignor and Assignee are parties to an Asset Purchase Agreement entered into on March 23, 2015 (the “APA”), pursuant to which Assignor agreed to transfer to Assignee all right, title, and interest in and to the Owned Business Intellectual Property.

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Definitions. All capitalized terms not otherwise defined in this Assignment shall have the same meaning as such terms have in the APA.

2. Assignment and Assumption. Assignor hereby sells, assigns, transfers, and conveys to Assignee all rights, title, and interest in and to the following, to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor if this sale, assignment, and transfer had not been made, and Assignee hereby assumes all rights, title, and interest in and to the following:

2.1. All Owned Business Intellectual Property;

2.2. With respect to all registered and unregistered trade names, trademarks, service names and service marks, designs, logos, emblems, signs or insignia, slogans or other similar designations of source and origin and general intangibles of like nature and applications for registration of the same that are Owned Business Intellectual Property (collectively, “Trademarks”), all goodwill of the Business associated with the use of and symbolized by the Trademarks, although for avoidance of doubt, the assignment of Trademarks granted herein does not include any trademarks listed in Schedule 2.3(f) to the APA, which are listed as Excluded Assets; and

2.3. All causes of action and rights of recovery for past, present, or future infringement of the Owned Business Intellectual Property.

3. Domain Name Transfer. The parties acknowledge that in order to effect the assignment and transfer of registration of any domain names and social networking identifiers listed on Schedule 1, the parties must follow certain procedures stipulated by the relevant registrar or website operator (the “Transfer Procedures”). If any further documents or agreements are required to be executed by the parties to carry out such Transfer Procedures, such documents or agreements shall form a part of this Assignment. The parties agree to cooperate fully with each other and promptly to take all necessary actions in order to comply with the

Transfer Procedures so as to effect the transactions contemplated in this Assignment, including Assignor directing any domain name registrar to release and unlock any domain names and, upon notice from the registrar that such domain names have been unlocked, immediately requesting that the domain names be transferred to Assignee. The parties acknowledge that it may not be possible to transfer ownership of certain social networking identifiers. In such instances, the parties will work together to accomplish an informal, unofficial transfer, such as Assignor providing Assignee with appropriate user names and passwords. If it is impossible to complete a transfer formally or informally or any social networking identifiers, then Assignor shall take reasonable steps to delete the social networking identifier(s) at issue.

4. Recordation of Assignments. Attached to this Assignment are the agreements for filing with the U.S. Patent and Trademark Office, and trademark offices in countries outside of the United States, to record the change of ownership of the Owned Business Intellectual Property that consists of registered and pending Trademarks (Schedule 2) and registered and pending patents (Schedule 3).

5. Further Assurances. Assignor agrees that, upon commercially reasonable request from time to time, it shall execute and deliver all such additional documents as may be required, and at Assignee's expense to do all other acts which may be necessary or appropriate, in the reasonable opinion of Assignee's counsel, to perfect or record the right or title of Assignee to the Owned Business Intellectual Property transferred hereby.

6. Amendment; No Waiver. This Assignment may only be amended, modified or supplemented by an agreement only in a writing signed by a duly authorized officer of each of Assignor and Assignee. No waiver by either party of any of the provisions hereof shall be effective unless explicitly set forth in writing and signed by the party so waiving.

7. Assigns. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns. This Agreement and the rights and obligations arising under this Agreement may not be assigned by Assignee or Assignor without the other's prior written consent, except that Assignee may assign this Agreement and its rights and obligations hereunder to any of its Affiliates (provided that Assignee shall remain responsible for its obligations hereunder to the extent such obligations are not performed by such Affiliate).

8. Applicable Law; Jurisdiction. This Assignment, the transactions contemplated hereby and the legal relations between the parties hereto shall be governed by and construed and enforced in accordance with the internal Laws of the State of Delaware without giving effect to the principles of conflict of law thereof. THE STATE AND U.S. FEDERAL COURTS LOCATED IN LOUISVILLE, KENTUCKY, SHALL HAVE EXCLUSIVE JURISDICTION OVER ANY AND ALL DISPUTES BETWEEN THE PARTIES HERETO, WHETHER IN LAW OR EQUITY, ARISING OUT OF THIS ASSIGNMENT AND THE PARTIES CONSENT TO AND AGREE TO SUBMIT TO THE EXCLUSIVE JURISDICTION OF SUCH COURTS.

9. Counterpart; Electronic Documents. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute

one and the same instrument. Facsimile or signed documents delivered by email or other electronic means shall be deemed to be original signed documents for all purposes hereunder.

With respect to the U.S. Trademarks, to the extent that an application for any Mark is based on intent-to-use and no allegation of use under Section 1(c) or 1(d) of the Lanham Act has been filed for such application, Assignor is assigning each such Mark and accompanying application as part of the entire business or portion thereof to which the Mark pertains as required by Section 10 of the Lanham Act.




