**TERMINATION AND RELEASE OF
SECURITY INTEREST IN PATENTS AND TRADEMARKS**

WHEREAS R. P. Lumber Co., Inc., an Illinois corporation ("RP Lumber"), R.P. Acquisition Corporation, an Illinois corporation ("RP Acquisition"); RP Lumber and RP Acquisition are each a "Borrower" and collectively, "Borrowers", executed that certain Amended and Restated Loan and Security Agreement dated December 3, 2021 (the "Loan Agreement") in favor of U.S. Bank National Association, as Administrative Agent (the "Administrative Agent") and the Lenders from time to time party thereto.

WHEREAS, Borrowers granted the Administrative Agent, for the benefit of the Lenders, under the terms of the Loan Agreement and pursuant to that certain Grant of Security Interest (Patents and Trademarks) dated December 3, 2021 executed by Borrowers in favor of Administrative Agent, for the benefit of the Lenders, a continuing security interest (the "Security Interest") in favor of the Administrative Agent, in and to the Patents (as defined in the Security Agreement) and Trademarks (as defined in the Loan Agreement), including without limitation the patents and trademarks listed on Schedule A hereto and all of the goodwill of the business connected with the use of, and symbolized by the Patents and Trademarks, as well as all proceeds and claims based on past, present, or future infringement thereof.

WHEREAS, notice of Administrative Agent's Security Interest in the Patents and Trademarks was previously recorded on December 10, 2021 at the United States Patent and Trademark Office at Reel 7525, Frame 0510.

WHEREAS, the Administrative Agent has agreed to terminate and release its Security Interest in all of the Patents and Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, (a) the Administrative Agent hereby releases, terminates and discharges any and all of its interest in the intellectual property of Borrowers, including the Patents and Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Patents and Trademarks, (b) the Administrative Agent hereby assigns, transfers and conveys to Borrowers any interest in such intellectual property and the Patents and Trademarks, including the Security Interest and any other liens, and (c) the Administrative Agent and Borrowers agree that the Security Interest is hereby terminated in its entirety and shall be of no further force and effect, in the case of each of clauses (a), (b) and (c), without recourse and without representation or warranty of any kind (express or implied).
