**NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Trademark Release”) is made as of April 20, 2022, by BANK OF AMERICA, N.A., a national banking association with an address at One Bryant Park, New York, NY 10036, as the Administrative Agent (the “Grantee”), in favor of CLARK EQUIPMENT COMPANY, a Delaware Corporation with an address at 250 East Beaton Drive, West Fargo, ND 58078 (the “Grantor”).

**WITNESSETH:**

WHEREAS, the Grantor and the Grantee are party to that certain Security Agreement, dated as of May 18, 2017 (as amended, supplemented, restated or otherwise modified from time to time, the “Security Agreement”) entered into pursuant to that certain Credit Agreement, dated as of May 18, 2017 (as amended, supplemented, restated or otherwise modified from time to time) by and among Doosan Bobcat Inc., the Grantor, certain other parties, and the Grantee;

WHEREAS, in furtherance of the Security Agreement, the Grantor and the Grantee entered into that certain Trademark Security Agreement dated as of May 18, 2017 (the “Trademark Security Agreement”), pursuant to which the Grantor granted to the Grantee for the benefit of the Secured Parties, a security interest in the Trademark Collateral (as that term is defined in the Trademark Security Agreement), including but not limited to the Trademarks listed on Schedule A attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 15, 2017 at Reel 6085, Frame 0226;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Trademark Release, the Grantee agrees as follows:


1. Definitions. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement or the Trademark Security Agreement, as applicable.
2. Release. The Grantee, without recourse, representation or warranty of any kind, hereby releases, terminates and discharges its security interest in and to the Trademark Collateral, including but not limited to the Trademarks listed on Schedule A attached hereto, if any. The Grantee, without recourse, representation or warranty of any kind, hereby terminates and cancels the Trademark Security Agreement. This Trademark Release shall be binding upon the parties hereto and their successors and assigns.
3. Recordation. The Grantee and the Grantor, at the Grantor’s sole cost and expense, authorize and request the United States Patent and Trademark Office to record this Trademark Release against the Trademark Collateral. The Grantor agrees to perform all further acts and execute and deliver all further documents and/or instruments that may be reasonably necessary to carry out the provisions of this Trademark Release.

4. Governing Law. This Trademark Release and the rights and obligations of the parties hereunder shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.




