Saint Louis, Batesville, Arkansas 72501, USA, hereafter "BATTLE ARMOR," is desirous of acquiring the entire right, title and interest in and to the above-referenced trademarks (collectively, the "Trademarks"), in both the United States and any other countries

throughout the world therefor, along with all right, title and interest in, to and under the Trademarks;

NOW, THEREFORE, for and in consideration of benefits in hand provided by BATTLE ARMOR and for other good and valuable considerations, the receipt of which is hereby acknowledged, BAD BOY does hereby sell, assign, transfer and set over to BATTLE ARMOR, all right, title and interest in and to the Trademarks, including any and all applications for such Trademarks, in the United States and other countries throughout the world therefor, including any and all divisions, continuations, reexaminations and reissues thereof, the same to be held and enjoyed by BATTLE ARMOR for its own use and benefit, and for the use and benefit of its successors, assigns, or other legal representatives, to the end of the term or terms for which said Trademarks of the United States or foreign countries are or may be granted, reexamined or reissued, as fully and entirely as the same would have been held and enjoyed by BAD BOY if this assignment and sale had not been made.

And BAD BOY hereby authorizes and requests the Commissioner of Patents and Trademarks issue any and all appropriate letters of the United States on said Trademarks from said application and from any and all divisions, continuations, and reissues thereof, to BATTLE ARMOR, as assignee of its entire interest.

And BAD BOY further hereby agrees that it will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said Trademarks as may be granted therefor, to BATTLE ARMOR, its successors, assigns, or other legal representatives and that if BATTLE ARMOR shall desire to file any divisional or continuation applications or to secure a reexamination or reissue of such Trademarks, or to file a disclaimer relating thereto, will upon request, sign all papers, make all rightful oaths and do all lawful acts

requisite for the filing of such divisional or continuation application, or such application for reissue and the procuring thereof, and for the filing of such disclaimer.


And BAD BOY further agrees to promptly obtain a release of any pending security interest granted by BAD BOY in and to the Trademarks, including a release of the security interest granted by BAD BOY in favor of BNP Paribas, as administrative agent for certain Lenders (as such term is defined in the Grant of Trademark Security Interest executed by BAD BOY on or about March 12, 2021), and to deliver written evidence of such release to BATTLE ARMOR.

And BAD BOY does further agree that it will, at any time upon request, communicate to BATTLE ARMOR, its successors, assigns or other legal representatives, such facts relating to said Trademarks or the file history thereof as may be known to it or its employees, and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of BATTLE ARMOR, its successors, or other legal representatives.
