ASSIGNMENT OF MARK

THIS ASSIGNMENT OF MARK (this “*Assignment*”) is made as of April 29, 2022 by Cox Radio, LLC, a Delaware limited liability company (“*Assignor*”) to Spanish Broadcasting System of Greater Miami, Inc., a Delaware corporation (“*Assignee*”).

This Assignment of Mark is made pursuant to that certain Asset Purchase Agreement, dated February 10, 2022 (the “*Agreement*”) by and among Assignor, CXR Radio, LLC, a Delaware limited liability company, as trustee of the CXR Radio Station Trust, Assignee and certain Affiliates of Assignee, with respect to, among other things, the following radio station (the “*Station*”):

Assignor is a limited liability company organized under the laws of the State of Delaware, having its principal office at 1601 W. Assignee is a corporation organized under the laws of the State of Delaware, having its principal office at 7007 NW. 77th Ave., Miami, FL 33166, and desires to acquire the Mark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to the Agreement, Assignor hereby transfers, assigns, conveys and delivers to Assignee, its successors and assigns, all of Assignor’s right, title and interest in, to and under the Mark (including the registrations thereof and applications therefor (wherever filed)), whether statutory or at common law, together with the goodwill, if any, associated with the use of the Mark, free and clear of Liens other than Permitted Liens.

This Assignment is subject in all respects to the terms and conditions of the Agreement. Nothing contained in this Assignment shall be deemed to supersede, amend, enlarge or rescind any of the covenants, agreements, representations or warranties of Assignor or Assignee contained in the Agreement.

The construction and performance of this Assignment shall be governed by the laws of the State of Delaware without giving effect to the choice of law provisions thereof.

Capitalized terms used herein and not otherwise defined shall have the respective meanings set forth in the Agreement.

This Assignment may be executed in several counterparts, each of which shall be deemed an original, but such counterparts shall together constitute but one and the same instrument. Delivery of a manually or digitally executed signature page of this Assignment and/or transmission of such signature page by facsimile or in a .pdf or similar electronic file shall be effective as delivery of a manually executed counterpart hereof.

At any time and from time to time after the date hereof, Assignor shall execute and deliver or cause to be executed and delivered to Assignee such other instruments and take such other action, all as Assignee may reasonably request, in order to carry out the intent and purpose of this Assignment.


