**TERMINATION AND RELEASE OF
GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS**

This **TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (this “Release Agreement”), dated as of December 17, 2021 is made by **ABNER DOUBLEDAY LLC**, a New York limited liability company (the “Grantor”) in favor of **SANDLOT ACQUISITION, LLC**, a Delaware limited liability company (the “Grantee”).

WHEREAS, the Grantor and the Grantee are parties to that certain Senior Convertible Secured Promissory Note dated as of July 21, 2020 in which the Grantor delivered to the Grantee that certain Trademark Security Agreement (the “Agreement”) whereby the Grantor granted the Grantee a security interest in certain trademarks of the Grantor, including the trademarks and trademark applications listed on **Schedule A** attached hereto (the “Secured Trademarks”) for recordation with the United States Patent and Trademark Office (the “USPTO”); and

WHEREAS, the Agreement was recorded with the United States Patent and Trademark Office on July 21, 2020 at Reel 007004, Frame 0777; and

WHEREAS, the obligations secured by said security interest have been paid in full or otherwise satisfied; and

WHEREAS, the Grantee has agreed to terminate and release its security interest and all of its right, title and interest in each of the Secured Trademarks, as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby agrees as follows:


1. **Release and Assignment**. The Grantee hereby discharges, terminates and releases its security interest in all of the Secured Trademarks, and the Grantee hereby assigns and transfers to the Grantor, without recourse, all of the Grantee’s right, title and interest in and to each of the Secured Trademarks and the related registrations and goodwill, effective as of the date set forth above.

2. **Further Assurances**. The Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release Agreement at the Grantor’s sole cost and expense.
