**PARTIAL TERMINATION AND RELEASE OF PATENT, TRADEMARK AND  
COPYRIGHT SECURITY AGREEMENT**

**THIS PARTIAL TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of April 25, 2022, and made by **PNC BANK, NATIONAL ASSOCIATION** (the "Collateral Agent"), to **SL POWER ELECTRONICS CORPORATION**, a Delaware corporation (the "Grantor").

WHEREAS, pursuant to that certain Patent, Trademark and Copyright Security Agreement dated as of November 14, 2017, made by Grantor in favor of Collateral Agent (the "IP Security Agreement"), and pursuant to that certain Supplement to Patent, Trademark and Copyright Security Agreement dated as of December 29, 2021, made by Grantor in favor of Collateral Agent (the "Supplement"), a security interest was granted by the Grantor to Collateral Agent in certain collateral, including the Specified Intellectual Property (as hereinafter defined);

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on December 4, 2017 at Reel/Frame 6219/0245;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on December 4, 2017 at Reel/Frame 044678/0939;

WHEREAS, the IP Security Agreement was recorded with the United States Copyright Office on December 15, 2017 at Volume/Document 9954/808;

WHEREAS, the Supplement was recorded with the United States Patent and Trademark Office on December 30, 2021 at Reel/Frame 058600/0571;

WHEREAS, the Supplement was recorded with the United States Patent and Trademark Office on December 31, 2021 at Reel/Frame 7546/0709;

WHEREAS, pursuant to that certain Patent, Trademark and Copyright Security Agreement dated as of August 9, 2012, made by Grantor in favor of Collateral Agent (the "2012 IP Security Agreement"), a security interest was granted by the Grantor to Collateral Agent in certain collateral, including the Specified Intellectual Property (as hereinafter defined);

WHEREAS, the 2012 IP Security Agreement was recorded with the United States Patent and Trademark Office on August 16, 2012 at Reel/Frame 28802/0081;

WHEREAS, the 2012 IP Security Agreement was recorded with the United States Patent and Trademark Office on August 16, 2012 at Reel/Frame 4844/0469;

WHEREAS, Collateral Agent now desires to terminate, release and discharge its security interests in the Specified Intellectual Property defined below;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Collateral Agent hereby states as follows:

1. Definitions. The term “Specified Intellectual Property,” as used herein, shall mean all of the Grantor’s right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Exhibit A hereto.

2. Release of Security Interest. Collateral Agent hereby terminates, releases and discharges its security interests in the Specified Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Collateral Agent in the Specified Intellectual Property.
