**RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS**

This **RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS**, dated as of April 29, 2022 (this “**Release**”), is made by **MIDCAP FINANCIAL TRUST**, in its capacity as collateral agent for Secured Parties (in such capacity, the “**Collateral Agent**”) as defined in the Pledge and Security Agreement referred to below. All capitalized terms used, but not otherwise defined herein, shall have the meanings set forth in the Pledge and Security Agreement or in the Intellectual Property Security Agreements referred to below.

**WHEREAS**, in connection with that certain Pledge and Security Agreement, dated as of December 3, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the “**Pledge and Security Agreement**”), by and among the Grantors and the Collateral Agent, the Grantors, as collateral security for the Secured Obligations, granted to the Collateral Agent a security interest in and continuing lien on all of their right, title and interest in, to and under the Collateral, including without limitation, certain Intellectual Property of the Grantors;

**WHEREAS**, in connection with the Pledge and Security Agreement and pursuant to those certain agreements described on Annex I attached hereto (collectively, the “**Intellectual Property Security Agreements**”), certain of the Grantors granted to the Collateral Agent a security interest in their Intellectual Property Collateral (as defined in the Intellectual Property Security Agreements); and

**WHEREAS**, the Intellectual Property Security Agreements were recorded in the United States Patent and Trademark Office or the United States Copyright Office, as applicable, on the dates and on the reel and frame numbers set forth on Annex I hereto.

**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby releases, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its lien on and security interest in, and right of setoff against the Intellectual Property Collateral, whether granted pursuant to the Intellectual Property Security Agreements or any other agreement or document delivered in connection with the Pledge and Security Agreement, and the Collateral Agent hereby reassigns any and all such right, title and interest (if any) that the Collateral Agent may have in, to and under the Intellectual Property Collateral to the Grantors.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
