TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Termination and Release”) is made as of the 28th of April, 2022, by EAST WEST BANK (the “Administrative Agent”) to T-BEV, INC., an Oregon corporation (“Grantor”). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement (defined below) or the Security Agreement (defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Security and Pledge Agreement, dated as of June 3, 2021, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among, *inter alios*, the Grantor and the Administrative Agent, the Grantor executed that certain Notice of Grant of Security Interest in Trademarks, dated as of June 3, 2021, which was recorded in the United States Patent and Trademark Office at Reel 7315, Frame 0344 on June 3, 2021 (the “Trademark Security Agreement”), pursuant to which the Grantor granted a security interest to the Administrative Agent in the Grantor’s Trademarks, including certain trademarks and/or trademark applications listed on Schedule A attached hereto and made a part hereof.

WHEREAS, the Administrative Agent now desires to terminate and release its security interest in the Trademarks and reassign any and all rights, title, and interest in the same to the Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. The Administrative Agent hereby releases its security interest in all of the Grantor’s right, title and interest in and to the Trademarks, including those Trademarks set forth on Schedule A.

2. If and to the extent that the Administrative Agent has acquired any right, title or interest in or to any of the Trademarks, the Administrative Agent hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Administrative Agent, any and all of its right, title, and interest in and to the Trademarks (including without limitation those Trademarks set forth on Schedule A), along with any goodwill in the Trademarks that the Administrative Agent may have acquired.

3. This Termination and Release, and any claims, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Termination and Release and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the law of the State of New York.


