

GRANT OF SUPPLEMENTAL SECURITY INTEREST IN TRADEMARKS

THIS GRANT OF SUPPLEMENTAL SECURITY INTEREST IN TRADEMARKS (this "Supplemental Grant") is made and dated effective the 24th day of March, 2022 by and between RAISING CANE'S USA, L.L.C., a Louisiana limited liability company (the "Grantor"), with principal offices at 6800 Bishop Road, Plano, Texas 75024, and CAPITAL ONE, NATIONAL ASSOCIATION, as Administrative Agent (the "Grantee") with principal offices at 800 Delaware Avenue, Wilmington, Delaware 19801, under the Guaranty and Security Agreement among Grantor, the other grantors from time to time party thereto and the Grantee, dated as of November 25, 2020 (as the same may be amended, restated, modified and/or supplemented from time to time, the "Guaranty and Security Agreement").

RECITALS

- A. Pursuant to the Guaranty and Security Agreement, Grantor and Grantee previously entered into a Grant of Security Interest in Trademarks on November 25th, 2020 (the "Grant").
- B. Grantor and Grantee hereto desire to supplement the Grant to include certain United States trademarks registered or pending with the United States Trademark and Patent Office ("<u>USPTO</u>") that were not covered by the previous Grant.

NOW, THEREFORE, in consideration of the above Recitals and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto hereby agree as follows:

AGREEMENT

Grantor hereby grants to Grantee a security interest in all of the Grantor's right, title and interest in and to the trademarks, trademark registrations, and trademark applications (the "Marks") set forth on Schedule B attached hereto and all reissues, extensions or renewals thereof, and the goodwill of the businesses with which the Marks are associated; in each case together with all Proceeds (as such term is defined in the Guaranty and Security Agreement) of the Marks, and all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

This Supplemental Grant is made to secure the satisfactory performance and payment of all the "Secured Obligations" of the Grantor, as such term is defined in the Guaranty and Security Agreement.

THE SECURITY INTEREST IN THE MARKS BEING GRANTED HEREUNDER SHALL NOT BE CONSTRUED AS AN ABSOLUTE ASSIGNMENT, BUT AS AN ASSIGNMENT TO SECURE GRANTOR'S OBLIGATIONS TO GRANTEE UNDER THE GUARANTY AND SECURITY AGREEMENT.

This Supplemental Grant has been granted in conjunction with the security interest granted to the Grantee under the Guaranty and Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to, and are in addition to, those set forth in the Guaranty and Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Supplemental Grant are deemed to conflict with the Guaranty and Security Agreement, the provisions of the Guaranty and Security Agreement shall govern. This Supplemental Grant may be executed in counterparts. To the extent applicable, the parties hereto authorize and request that the Commissioner of Patents and Trademarks of the United States record this security interest in the Marks.

The terms of Sections 10.04, 10.05, 10.16 and 10.17 of the Guaranty and Security Agreement with respect to expenses, indemnity, governing law, submission to jurisdiction, venue and waiver of right to trial by jury are incorporated herein by reference, *mutatis mutandis*.
