**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), dated as of April 28, 2022, is made by **SIXTH STREET SPECIALTY LENDING, INC.**, a Delaware corporation (f/k/a TPG Specialty Lending, Inc.), in its capacity as collateral agent for the Lenders (in such capacity, together with its successors and assigns in such capacity, "Agent"), in favor of **STORMSOURCE, LLC**, an Arizona limited liability company, as the grantor listed on the signature pages of the Stormsource Trademark Security Agreement (as defined below) ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of December 18, 2020, (as amended, restated, supplemented, or modified from time to time, the "Stormsource Trademark Security Agreement"; capitalized terms used herein without definition shall have the meanings ascribed thereto in the Stormsource Trademark Security Agreement), by and among Agent and Grantor, Grantor granted, assigned and pledged to Agent, a continuing security interest in all of Grantor's right, title and interest in and to the Trademark Collateral owned or thereafter acquired (the "Security Interest");

WHEREAS, the Stormsource Trademark Security Agreement was recorded at the United States Patent and Trademark Office on December 18, 2020 at Reel 7184, Frame 0311; and

WHEREAS, Agent has agreed to terminate and release its Security Interest in Grantor's entire right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral, including those identified on Schedule A attached hereto.

NOW, THEREFORE, for valuable consideration, Agent hereby terminates, discharges, cancels and releases all mortgages, liens, collateral assignments, pledges and Security Interest granted to Agent in the Trademark Collateral.

Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in, to and under the Trademark Collateral.

Agent agrees to take all further actions, and provide to Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor, at Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Termination.
