## ASSIGNMENT OF TRADEMARK

Whereas, Assignor wish to assign their rights in the Trademarks to Assignee.

Now, Therefore, in consideration of the mutual promises, covenants, warranties, and other good and valuable consideration set forth herein, the Parties agree as follows:

**1. ASSIGNMENT:** Assignor hereby irrevocably and unconditionally conveys and assigns to Assignee (a) all of their right, title, and interest in and to the Trademarks, same to be held by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment had not been made; and (b) all rights to income, royalties, and license fees deriving from the Trademarks, all claims for damages by reason of past, present and future infringements of the Trademarks or injury to the goodwill associated with the Trademarks, and the right to sue for and collect such damages, as permitted under the applicable laws for any jurisdiction or country in which such claims may be asserted for the use and benefit of Assignee and its successors, assigns and other legal representatives.

**2. Continuing Obligations:** Assignor agree to perform all reasonable acts that are reasonably necessary to permit and assist Assignee or its successor or assignee in perfecting its rights in the Trademarks. Such acts may include executing additional documents and assisting and cooperating in the registration, enforcement and defense of the Trademarks. Assignee agrees to defend and hold harmless Assignor against any past, present or future claims against the use of the Trademarks due to acts or omissions of the Assignor.

**3. No Continuing Obligations:** Assignee has no continuing obligation to seek registration of the Trademarks or enforcement of the rights in the Trademarks. Assignee will have the sole control over the activities related to the prosecution, enforcement and defense of the Trademarks.
