**RELEASE OF TRADEMARK SECURITY INTEREST**

This Release of Trademark Security Interest (“Release”) is given on this 29th day of April 2022, by ANTARES CAPITAL LP, as the administrative agent (the “Administrative Agent”) for each of the Secured Parties to TCA, LLC (f/k/a Aero Media LLC) (the “Grantor”), as follows:

WHEREAS, on September 10, 2018, the Grantor and the Administrative Agent entered into a Trademark Security Agreement (“Security Agreement”);

WHEREAS, pursuant to said Security Agreement, the Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, among other collateral, a continuing security interest in all of the Grantor’s right, title and interest, including goodwill, in, to and under its United States trademarks, including but not limited to the trademarks listed on the attached Schedule A (the “Trademarks”);

WHEREAS, said Security Agreement was recorded in the United States Patent & Trademark Office on September 12, 2018, at reel/frame 6447/0232.

WHEREAS, the Administrative Agent wishes to release its security interest in the Trademarks listed on Schedule A and retransfer and reassign to the Grantor without recourse all of the Administrative Agent’s right, title and interest in and to the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself and each of the Secured Parties, hereby covenants and agrees as follows:

The Administrative Agent hereby releases any security interest it may have in the Trademarks listed on Schedule A, and reassigns any and all right, title and interest it may have in and to the Trademarks without recourse to the Grantor.

The Administrative Agent hereby agrees to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
