**TRADEMARK ASSIGNMENT**

This Trademark Assignment, effective as of April 25, 2022 ("Effective Date"), is between Nar Enterprises LLC, a limited liability company formed under the laws of the State of Wyoming with a place of business at 1525 S Higley Road, Ste 104, PMB 1372, Gilbert, Arizona, 85296 ("Assignor"), and eSpring GmbH, a Gesellschaft mit beschränkter Haftung formed under the laws of Germany with a place of business of c/o MXP Prime Platform, Koppenstr. 93, Berlin, Germany 10243 ("Assignee").

WHEREAS, Assignor is the owner of all of the right, title and interest in and to the trademark GOURMEO that is the subject of U.S. Trademark Application Serial No. 90/359673 therefor (respectively, the "Mark" and the "Application"), and all of the goodwill and business associated and connected with the Mark, and desires to assign, transfer and sell to Assignee its ownership in the Mark, all of the goodwill associated therewith, and the portion of its business connected to the Mark and the Application; and

WHEREAS, Assignee is desirous of acquiring Assignor's entire ownership interest in the right, title and interest in and to the Mark, all of the goodwill associated therewith, the portion of Assignor's business connected with the Mark and the Application.

NOW, THEREFORE, for One Dollar (\$1.00) and other fair and good consideration, the receipt of which is hereby acknowledged, Assignor, as of the Effective Date, hereby assigns, transfers and sells to Assignee, its successors, and assigns, Assignor's entire ownership interest in the right, title and interest in and to the Mark, the goodwill associated therewith, the portion of Assignor's business connected with the Mark, the Application, any registrations therefrom, renewals thereof, all income, royalties, damages, and payments now or hereafter due or payable



with respect to the Mark, all causes of action (in law and/or equity) and the right to sue, counterclaim, and recover for past, present, and future infringement, misappropriation, or dilution of the rights assigned to Assignee hereunder, and all rights, including the goodwill, corresponding thereto.

Assignor, as of the Effective Date, agrees to immediately cease using the Mark and further agrees, without further consideration, to cause to be performed such lawful acts and to execute such further documents regarding the rights assigned, transferred and sold herein, as reasonably requested by Assignee or its successors or assigns.
