**SECOND LIEN RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS SECOND LIEN RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the “Release”), dated as of April 21, 2022, is made by MORGAN STANLEY SENIOR FUNDING, INC., as collateral agent (in such capacity, together with its successors and assigns, the “Collateral Agent”) in favor of CHROMAFLO TECHNOLOGIES CORPORATION, an Ohio corporation (the “Grantor”).

**WHEREAS**, by (i) that certain Second Lien Security Agreement, dated as of May 7, 2021, in favor of the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Second Lien Security Agreement”) and (ii) that certain related Second Lien Trademark Security Agreement, dated as of May 7, 2021, in favor of the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Second Lien Trademark Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Second Lien Security Agreement or Second Lien Trademark Security Agreement, as applicable), which Second Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the “USPTO”) on May 7, 2021 at Reel 7285 Frame 0765, the Grantor pledged, assigned and granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantor’s right, title and interest in, to and under the Trademark Collateral, including those Trademarks listed on Schedule I hereto;

**WHEREAS**, the Grantor desires the Collateral Agent to release, discharge, terminate and cancel its lien on and security interest in the Trademark Collateral, including, without limitation, the Trademarks set forth on Schedule I hereto;


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent, on behalf of the Secured Parties, does hereby (a) terminate the Second Lien Trademark Security Agreement, (b) release, discharge, terminate and cancel any and all of its right, title and interest in and to the Trademark Collateral, including any and all goodwill relating to the same, and (c) reassigns, transfers and conveys to the Grantor any and all of its rights, title and interests in the Trademark Collateral.

The Collateral Agent authorizes the Grantor to record this Release with the USPTO and authorizes and requests that the Commissioner for Trademarks and any other applicable government authority record this Release. The Collateral Agent hereby agrees, at the Grantor’s sole cost and expense, to duly execute, acknowledge, procure and deliver any further documents prepared by the Grantor and to take such other actions as may be reasonably requested by the Grantor to release and terminate any and all security interests and other liens in the Trademark Collateral set forth on Schedule I.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
